NATIONAL CLASS INFORMATION

Amateur Classes (AA)

- Individuals possessing current amateur certification are only eligible as Adult Amateurs from the beginning of the calendar year in which they reach age 22.
- Only active United States Equestrian Federation members may obtain amateur status. (Exception: Equine Canada members in possession of current EC membership may sign for USEF Amateur status on a show by show basis at no cost).
- Participants must possess current USEF Amateur status and qualify under the USEF Amateur rules.
- If opportunity classes at Dressage Competitions are restricted to amateurs, riders are required to have an amateur status with USEF.

Junior/Young Rider Classes (JR/YR)

- Riders are eligible to compete in these classes until the end of the calendar year in which they reach the age of 21.

Pony Division

- For this competition, classes are offered for FEI Pony Team, Pony Individual & Pony Freestyle. The pony division is open to all breeds that meet the following measurement requirements. In the Dressage Division, a pony is an animal that does not exceed 148 cm (14.23h) without shoes, and 149 cm (14.27h) with shoes. The pony can be of any sex (Mare, Stallion, or Gelding).
- Ponies under the age of eight and in possession of a valid temporary card from another division or discipline should submit a copy with their entry.
- Measurement will be required for these pony specific classes if they do not currently have a valid measurement card. Measurement will be yearly beginning from the age of three (36 months) until the pony has reached the age of eight years. Animals three through seven years old will be issued an annual Temporary Certificate of Measurement and must be re-measured annually until the age of eight years. Animals eight years and older will be issued Standard Certificates of Measurement which will not need to be renewed. Measurement must be done on USEF Combined Driving and Dressage Pony Measurement form. Individual responsible for presenting the pony for measurement must be 18 years old. Animals submitted for measurement or re-measurement must show no evidence of lameness, and must be jogged for soundness prior to the measurement. Animals showing evidence of lameness are not eligible for measurement or re-measurement.
- Pony must be entered in show, USEF Technical Delegate and Show Veterinarian must be present for measurement. If Show Veterinarian is 'On-Call' there may be a charge for their visit which is the responsibility of rider/owner of pony. Pony measurements will be on Friday 4:00 pm – 5:00 pm.
- Please contact show management at least 7 days prior to show if you need to have a pony measured.

Opportunity Classes

- Riders/Horses competing only in "opportunity" classes are exempt from membership requirements and do not have to pay NM, HID or USEF drug fees. In addition, owners, trainers & coaches are exempt from membership requirements for these classes. While membership requirements are waived for riders in "opportunity" classes all USEF Dressage Division rules apply (including dress & saddlery requirements) in addition to all applicable General Rules & Medications. "Opportunity" riders & horses may cross enter into non-opportunity classes, but if you do so all USEF/USDF membership requirements & fees will apply. Scores earned in "opportunity" classes may not be used toward USEF/USDF awards programs.

Classes Per Day

- Horses are limited to a maximum of three Dressage rides per day at Fourth Level and below (including Rider Tests) or two Dressage rides per day above Fourth Level. Horses competing at both Fourth Level and Prix St. Georges, or their equivalents, are limited to two Dressage rides per day. Dressage Seat Equitation, Quadrille, Pas de Deux and Materiale classes are excluded from the maximum limit of rides per day and horses in these classes may compete at any level for which they are otherwise eligible during the same competition.

Consecutive Levels

Horses may enter no more than two consecutive levels, Freestyle levels included, at any one competition.

NOTE: Intermediaire I and Intermediaire II are NOT consecutive levels.

Scheduling & Ride Times

Classes may be split or combined at show management's discretion. Ride times will be e-mailed at least three days prior to the show. Schedules and results will also be made available for download and viewing at <https://results.equestrian-hub.com/dwec>. Official ride times will be posted in the Show Office by NOON prior to the first day of competition. **Classes may not necessarily be run in the order listed above.**

Results

This show will be utilizing 100% electronic results via the [Black Horse One eDressage System](#). Each competitor Will be issued access credentials to view or download their official results at the email specified on their entry Form. Results are available instantly following each ride at [edressage.live](#). *While results are available immediately following your ride, test sheets are not available for viewing until the Class/Competition has been closed and finalized.*

Awards

- Rosettes first through sixth place for each class. Divisions (JR/YR, AA, Open) may be run concurrently as one class. Divisions will be pinned separately. Riders must clearly specify division choice. When no designation is made, riders will automatically be entered as Open. Riders may enter only one division per class. Additional prizes and awards will be posted in the Show Office.
- High Point Awards for each division awarded daily. Ties will be broken per USEF DR123.

Musical Freestyles

Music must be on good quality CD and must be presented to the announcer at least 2 hours before scheduled ride. The schedule for sound checks will be posted at the show office. All freestyle entries Training-Fourth must submit proof of at least a 63% at the highest class of the level and FEI levels at least a 60%

SOUND CHECKS ARE MANDATORY, anyone not present for sound checks will be scratched - no refunds. Music Should be emailed to Show Secretary in electronic form. Audio formats only – no video files.

Current Rules

- The rules may have changed from the current USEF Rule Book. It is the competitor's responsibility to check the current USEF Rule Book for any changes. Current rules can be found at the US Equestrian website, www.usef.org.

COVID-19 Protocols

Vaccinations/Coggins

No horse will be permitted on the grounds without the following:

- Negative Coggins & Proof of Vaccinations (per USEF GR845) - Equine Influenza Virus & Equine Herpes Virus (Rhinopneumonitis) within 6 months prior to competition.
- Out-of-State competitors must provide a Health Certificate.
- **NO REFUNDS WILL BE GIVEN IF RIGHT TO COMPETE IS DENIED BECAUSE VACCINATION DOCUMENTATION IS MISSING OR INCOMPLETE.**

No Shows

All "No Shows" that have not contacted the Show Office prior to their ride time to advise of a scratch will be considered a scratch for the remainder of the show. Time slots may be resold with no compensation to the competitor assigned the original ride time. Exhibitors enter with this understanding and agreement.

Non-Refundable Fees

Full payment is required for the balance of the entry for an entry to be processed. DevonWood accepts checks, money orders, and credit/debit card (all major cards accepted) for entry payments made prior to show. Do **not** send cash with mailed entries. All payments must be made in US Dollar. Foreign bank notes (checks) must specify USD.

Passing a bad check is a crime. It is the competitor (or payee's) responsibility to ensure that there are sufficient funds to make payment for the total balance of the entry. ***Entries that arrive without payment will not be processed.***

Check payments should be made payable to "**DevonWood Equestrian Centre.**" DevonWood reserves the right to convert check payments to electronic check/"EFT" payment. All check entry payments will be processed immediately at the time of receipt. *Foreign competitors:* checks must indicate payment in USD. Credit/debit card payments will be charged for the full amount listed on the entry at time of receipt.

Refunds

- **A \$50.00 cancellation fee will be deducted from all refunds, regardless of date.**
- Until closing date: all fees returned, less \$50 cancellation fee.
- After closing date: USEF Drug & Meds Fees, USDF Q Fees, and stabling fees refunded with note from qualified DVM
- **After June 1:** No refunds, of any type, for any reason.

Sharps Containers & Disposal (Per USEF GR1210.4)

Competition Management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100.00 for improper disposal of needles or other sharp disposable instruments.

PROTECTIVE HEADGEAR REQUIREMENTS

DR120 & GR801: Protective Headgear Protective headgear is defined as a riding helmet, which meets or exceeds current ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds, including non-competing riders, riders on non-competing horses, mounted participants in exhibition classes, and those competing in all classes and tests, including Para Dressage tests, must wear protective headgear as defined by this rule and otherwise in compliance with GR801. **The harness must be secured and properly fitted.** Any rider violating this rule at any time must immediately be prohibited from further riding until the headgear is properly in place. Protective headgear may be the same as or a coordinating color with the coat, and may include contrast coloring, accent, and crystal decoration.

ABOUT THE FACILITY

Arenas & Footing. Two arenas: one indoor competition arena, (20M X 60M), with warm-up (20M X 40M), both Equi-Base footing (sand mixed with Geotek fabric over rubber matting), and three outdoor competition arenas, (20M X 60M), with warm-up (sand over rubber matting).

An additional outdoor competition arena, 20M x 60M, with complementing warm-up, both hydro-active sand arena footing, may be used in the event that entry counts warrant an additional arena to be used. Lungeing area is located near lower stabling. No lunging in warm-ups or round pens unless specified.

Children & Pets. Absolutely NO DOGS ALLOWED on show grounds, except Medical Assistance Animals/Service Dogs, as permitted by law. Emotional support animals (ESA) are not permitted. If you choose to bring a non-equine to the show, it must remain outside the Main Gates at all times. Children must be supervised at all times.

Food. Due to current state regulations and count regulations, there will be limited concessions available on-site. Food/drink concessions will be available on show grounds with services by DevonWood Café. Gluten free, vegetarian, Vegan and dairy free options are available. All food is pre-packed, sealed and provisioned by the Coffee Cat Coffeehouse in Newberg, OR.

Parking. Reserved parking is available on a first come basis for a fee. Entire rig must fit within space, both length and width, to ensure clear fire lane. Electric hookups are available as a courtesy at the end of each stabling row (first come basis) and may be used between the hours of 7 pm through 7 am. Trailers and tow vehicles may park outside the main facility gates at no additional fee.

Stabling. No bedding provided in tack stalls. Additional bedding available for purchase on site. Bedding other than shavings or pellets prohibited. *Stalls may not be resold or sublet by exhibitors.* **Indicate stabling preference on entry but realize that stalls will be assigned based on horse's size, sex, and length of stay, not just on postmark date.** Stalls available Friday noon through Sunday evening. Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR222) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

ATTENTION COMPETITORS

Each competitor is responsible for supplying management with correct applicable numbers (USDF and USEF) for horse, owner, rider, and trainer, before the day(s) of the competition.

The scores of competitors who fail to supply correct numbers may not be counted toward national awards.

– USEF MOTORIZED VEHICLE STATEMENT –

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

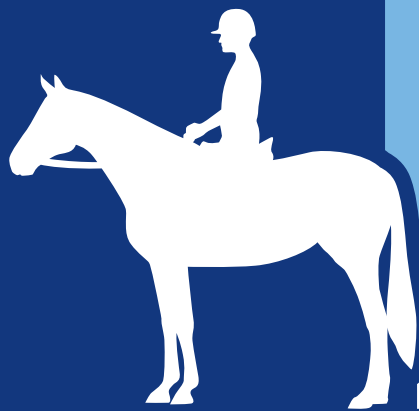

Regional Adult Amateur Equitation Program

The USDF Regional Adult Amateur Equitation Program recognizes adult amateurs competing in equitation and promotes correct seat, position, and use of the aids in dressage. An Adult Amateur Equitation Regional Final class presented by Big Dee's Tack and Vet Supply will be held in conjunction with each of the nine USDF Regional Dressage Championship competitions, providing adult amateurs with additional opportunity for recognition.

Ribbons awarded through 8th Place and gift certificates awarded to top three riders.

Adult amateurs wishing to qualify to compete in an Adult Amateur Equitation Regional Final may do so by meeting the following requirements.

Qualifying Requirements

To be eligible for the USDF Adult Amateur Equitation Regional Final class, rider must have

- a) Earned a score of 70% or higher in any dressage seat equitation class (except walk/trot) at a USEF-licensed/USDF-recognized Dressage competition within the qualifying period of the applicable regional championship.

or

- b) Qualified to compete in any regional dressage championship class (excluding freestyles).

Membership Requirements

- Rider must have a USDF Participating Membership at the time the qualifying score is earned, and at the time of the Regional Final class.
- Rider must be an adult amateur, in accordance with GR1306 of the USEF rules, and be designated with USEF as an adult amateur when the score is earned, and at the time of the Regional Final class.
- Owner must have a USDF Participating or Business Membership when the qualifying score is earned, and at the time of the Regional Final class.
- Horse must have a USDF Lifetime Horse Registration when the qualifying score is earned, and at the time of the Regional Final class.

USDF Statement on Animal Welfare

The United States Dressage Federation, Inc. (USDF), a federation of individual members and over 100 independent organizations throughout the United States, supports the concept of ethical treatment of animals.

Dressage is a classical method of training horses, based upon the horse's natural responses, as carried out in a gradual, planned program during which the horse's athletic abilities are improved in a systematic manner. As a result, the horse becomes capable, comfortable, and responsive in partnership with the rider without the use of force. Dressage competition at various levels of achievement is the ultimate test of the training program to determine whether the desired harmony between horse and rider has been achieved.

The rules pertaining to dressage competition prohibit the use of artificial appliances, training aids, and drugs, which would force the horse to submit. Instead, the emphasis is upon training and a cooperative partnership with the rider. Major competitions are carefully monitored to assure that there is no unnecessary force or harshness displayed.

Unlike other horse sports in which horses enter training at a relatively immature state, dressage training is usually not seriously begun until the horse is three or four. The top levels of achievement require five or more years of progressive training and it is not unusual to see horses in international competition in their late teens. This, in itself, places a premium on good care and soundness throughout the horse's life.

While supporting the concept of animal welfare in its broadest form, the United States Dressage Federation, Inc., also recognizes that it is unrealistic to ascribe human emotions and responses to the horse which in its wild state is a creature of flight, living a hard and precarious existence. Under domestication, the horse is assured of ample food, water, and shelter, as well as protection against infectious diseases and damaging parasites, thus leading a longer and healthier life with a high rate of survival.

As an educational organization, USDF has numerous programs, which teach people how to pursue the accepted, humane training methods. A program of certifying instructors also emphasizes protecting the horse's welfare in pursuit of dressage training.

Membership Requirements for USEF-licensed/USDF-recognized Competitions: Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$90), 5-years (\$360), or life (\$1,800). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$72). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program and the USDF Regional Schooling Show Awards Program.

Business Membership (BM): A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$240) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$35 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$35). Scores earned by a horse with an HID number will be recorded, but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$80. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$115) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

How to Join USDF

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

- On the USDF website: www.usdf.org. You can submit the application online or download the form and fax or mail it to the USDF office.
- In the show office at USEF-licensed/USDF-recognized competitions classified by USEF as Dressage Competitions, and Regular Competitions which are open to all breeds.

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.



2022 Great American Insurance Group/USDF Regional Dressage Championships

A single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), and recognized by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year. The Regional Championship Program Rules can be found on the USDF website at www.usdf.org. Please refer to the 2022 USDF Member Guide for the comprehensive list of rules and requirements for this program.

Membership/Registration Requirements for Qualifying and Championships

All memberships and registrations/recordings must be correct and current at the time qualifying scores are earned and at the time of the championships.

Rider:

- Must have a USDF Participating* Membership (PM).
- Must have a USEF membership (Active or Life).

Horse:

- Must have a USDF Lifetime Horse Registration (LHR).
- Must have a USEF (Annual or Lifetime) Horse Recording.
- USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s).

A horse is not required to have breed registry papers.

Owner:

- Must have a USDF Participating or Business Membership and a USEF membership (Junior Active, Senior Active, Life, or Recorded Farm (with Active Farm Owner)). If the horse has more than one owner, at least one owner must have both active USEF membership and active USDF Participating or Business Membership and must be the owner of record with USEF and USDF. For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both USEF and USDF.

* PMs are USDF members who join USDF directly. USDF Group Members (GM) are ineligible.

Minimum Qualifying Scores: One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for Training Level through Grand Prix, in three divisions: open, adult amateur and junior/young rider. FEI Junior and FEI Young Rider classes have only one respective division. Freestyles have only open divisions.

WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and **Ginny Rattner Memorial Dressage** ("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

EQUINE ACTIVITY LIABILITY ACT WARNING:

CAUTION: HORSEBACK RIDING AND EQUINE ACTIVITIES CAN BE DANGEROUS. RIDE AT YOUR OWN RISK.

Under the laws of most States, an equine activity sponsor or equine professional is not liable for any injury to, or the death of, a participant in equine activities resulting from the inherent risks of equine activities.

C. ASSUMPTION OF RISK: I understand that the aforementioned Risks may be caused in whole or in part or result directly or indirectly from the negligence of my own actions or inactions, the actions or inactions of others participating in the USEF Events, or the negligent acts or omissions of the Released Parties defined below, and I hereby voluntarily and knowingly assume all such Risks and responsibility for any damages, liabilities, losses, or expenses that I incur as a result of my participation in any USEF Events. I also agree to be responsible for any injury or damage caused by me, my horse, my employees or contractors under my direction and control at any USEF Event.

D. WAIVER AND RELEASE OF LIABILITY, HOLD HARMLESS AND INDEMNITY: In conjunction with my participation in any USEF Event, I hereby release, waive and covenant not to sue, and further agree to indemnify, defend and hold harmless the following parties: USEF, USEF Recognized Affiliate Associations, the United States Olympic & Paralympic Committee (USOPC), USEF clubs, members, Event participants (including athletes/riders, coaches, trainers, judges/officials, and other personnel), the Event owner, licensee, and competition managers; the promoters, sponsors, or advertisers of any USEF Event; any charity or other beneficiary which may benefit from the USEF Event; the owners, managers, or lessors of any facilities or premises where a USEF Event may be held; and all directors, officers, employees, agents, contractors, and volunteers of any of the aforementioned parties (Individually and Collectively, the "Released Parties" or "Event Organizers"), with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss, or expense (including court costs and reasonable attorney fees) of any kind or nature ("Liability") which may arise out of, result from, or relate in any way to my participation in the USEF Events, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties.

E. COMPLETE AGREEMENT AND SEVERABILITY CLAUSE: This Agreement represents the complete understanding between the parties regarding these issues and no oral representations, statements or inducements have been made apart from this Agreement. If any provision of this Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions.
